

Recognition of Prior Learning – Assessment Categories

1 Gymsport Coach Accreditation

Overview	Apply for this assessment if you would like to gain a GA Gymsport Coach Accreditation. A Gymnastics Australia Coach Accreditation acknowledges that you are competent to coach gymnastics, appropriate to your accreditation level. An accreditation enables you to become a Technical Member of GA.
Who is it for?	<p>An <u>Intermediate and Advanced Coach</u> Accreditation is for:</p> <ul style="list-style-type: none"> • An overseas coach • A local coach who does not hold a GA accreditation <p>An <u>Advanced Silver and High Performance</u> Coach Accreditation is for:</p> <ul style="list-style-type: none"> • An overseas coach
Restrictions	<p>The following restrictions apply:</p> <ul style="list-style-type: none"> • A coach cannot apply for a Beginner Coach Accreditation. Please complete the Beginner Online and Face to Face Course or alternatively apply to the State/Territory Association for an exemption to go straight to an Intermediate Coach Accreditation. • A local coach cannot apply for an Advanced Silver or High Performance Accreditation.

2 Temporary Gymsport Coach Accreditation (Advanced Silver only)

Overview	<p>This category is only available for an experienced international coach (Advanced Silver / High Performance). It enables the coach to begin working as soon as possible on arrival in Australia without having to go through the process of providing evidence of the theory of coaching.</p> <p>You will be observed coaching in the gym for your assessment. This Temporary Accreditation will only be issued at Advanced Silver.</p> <p>The coach will have an additional 6 months to provide evidence of the theory of coaching. Based on the evidence, a coach will be awarded a GA Accreditation (this could be higher or lower than Advanced Silver).</p>
Who is it for?	This accreditation is only available to an overseas coach.
Restrictions	<p>This accreditation is only:</p> <ul style="list-style-type: none"> • valid for 6 months • available at Advanced Silver
Additional requirements	The Coach must complete remaining parts of the RPL application within 6 months (all requirements are in the RPL Application Form).

3 Additional Gymsport Coach Accreditation

Overview	Apply for this assessment if you would like to gain an additional Gymsport Accreditation. You will only be assessed on new competencies, usually Gymsport specific.
Who is it for?	Appropriate for coaches who already hold a current GA accreditation at an equal or higher level.
Restrictions	This category is only available: <ul style="list-style-type: none"> to Technical Members of GA who hold a current coach accreditation. at Intermediate or Advanced Level.

4 Current Competency Coach Assessment

Overview	This category is available for coaches who have not renewed their Technical Membership for a period of three years or more. Apply for this assessment to verify that you are competent to coach at the level of your previous accreditation held. This assessment is a practical assessment at your workplace or alternative to prove you are still competent to coach.
Who is it for?	This assessment is for: <ul style="list-style-type: none"> A coach who has had an absence from coaching A coach who has not completed annual updating A coach who would like to undertake an assessment as updating
Restrictions	GA will make every effort to assess at the workplace but based on location, the coach may be required to travel to a convenient location / provide video or alternative evidence.
Additional requirements	This assessment is administered by the State/Territory Association. Please contact the State/Territory Association for this service.

5 FIG Judge Accreditation

Overview	Apply for this assessment if you are an overseas judge who holds a FIG Judge Accreditation.
Who is it for?	An overseas judge who holds a FIG Judge Accreditation
Additional requirements	Please contact Gymnastics Australia education@gymnastics.org.au and provide evidence of the accreditation.
